HOW ACCESS YOUR FAFSA - STUDENT AID REPORT (SAR)

Due: March 8, 2017

The California priority deadline to submit and file the 2017-2018 *Free Application for Federal Student Aid (FAFSA)* is **March 2, 2017**. However, you should check with your school's financial aid office to verify your school's individual deadline for this form. [Click here](#) for more information on the FAFSA.

If you are applying for an **Opportunity Scholarship**, the Pedrozzi Scholarship Foundation requires you to send a copy of your **FAFSA Student Aid Report** (*not your FAFSA*) to the Foundation by **March 8, 2017**.

Within 5-7 business days after you have filed your FAFSA, you will receive an email notifying you that your FAFSA has been processed and that your **Student Aid Report (SAR)** is now available. **PLEASE NOTE: Your SAR cannot automatically be sent to the Pedrozzi Scholarship Foundation - we do not have a FAFSA school code. It is your responsibility to follow these instructions and submit it to our office.**

At that point, please:

- Visit www.fafsa.gov and click the green 'Login' button in the center of the page.
- When prompted, enter the Student's Name, Social Security Number, and Date of Birth. Click 'Next'. You should see the words 'Current Application Status: Processed Successfully' on this screen in bold lettering.
- Click the blue button which reads 'View Processed Information'. On the following screen, enter the Student's 4-digit federal PIN number and Click 'Next'. You used this number to electronically sign your FAFSA.
- A separate window will open up with a five-page PDF. This is your **Student Aid Report (SAR)**. Save this document to your computer.
- If a separate window did not open with your SAR, please make sure that your pop-up disabler is turned off. *If you do not know how to disable your pop-up blocker, search Google or YouTube for your specific browser (Internet Explorer, Google Chrome, etc.) and instructions.*
- **Please make sure that we can see your full name and your Expected Family Contribution (EFC).** If your EFC is blank, corrections **MUST** be made.
- **This SAR is due to the Pedrozzi Scholarship Foundation by March 8, 2017.** If we do not receive your SAR by March 8, 2017, you will remain eligible for the scholarship you are applying (Community College, Undergraduate or Technical/Vocational), but will **NOT** be considered in the Opportunity Scholarship category. Your SAR cannot be submitted electronically. **It must be mailed to:**
